

NEWPORT CITY COUNCIL SPF GRANTS

Newport City Council's (NCC) Shared Prosperity Fund (SPF) grant allocations for sport, heritage and culture activities are supporting Newport City's future vision of becoming 'Ambitious, Fairer, Greener Newport For Everyone'. The grants will be managed by whatimpact.com and the application and evaluation process will take place on whatimpact's platform.

Whatimpact is a matchmaking platform for companies or grant makers and VCSEs (Voluntary, community and social enterprises). Whatimpact makes fundraising and finding partnerships easy and effective: you can search, match and report all in one place. The platform is free and simple to use.

To make an application you can simply follow these steps:

Check Your Eligibility

Charities, community groups, social enterprises, and other organisations can apply. The SPF grants aim to enhance social fabric and a sense of local pride through investment in activities that enhance physical, cultural, and social ties and access to amenities. They also aim to build resilient, healthy, safe neighbourhoods and to create innovative approaches to crime prevention. You must ensure that your projects address these objectives and interventions.



Select which Grant to Apply for

See Sports, Culture, and Heritage pages to see which category your project fits. Get in touch with whatimpact if you are unsure which grant scheme to apply for.



Create a Profile on whatimpact.com

Sign up on the website with your email and create a password. Select which type of organisation you are and begin creating your profile. We will provide a Word template to help with this. You need to add an overview of your organisation and add an activity, which is the project for which you are applying for funding. Make sure to read the specific criteria for the grant you are applying to. You must have an activity to apply!



Apply!

Go to the Newport City Council profile and click 'Apply'. You will need to answer some short due diligence questions and then you are done! It is very simple to apply using your profile and once you have applied you will hear back within a couple of weeks with any questions or if the grant has been allocated.
