

SPORTS GRANT

Projects must tackle inequality; they must be accessible and reach those most affected by the cost-of-living crisis. They must contribute to the goal of creating equal opportunities for all people in Newport regardless of socio-economic backgrounds, disabilities, sexual orientation, ethnicity, age, location, and health status. Projects, events, and activities must remain conscious of environmental impact, and consider their waste and CO₂ generation.

Grants can be applied for a single purpose or a combination of materials, events, spaces, equipment, technology, project, salaries, services and running costs of projects. Projects must benefit the local community either directly or through benefits created by e.g. increased number of visitors and business opportunities. The grants are restricted meaning they must be used solely for the projects/activities presented in the application process. Grant sizes vary from £1,000 - £30,000.

The sports grants may be awarded for projects such as sports events, sports club activities, health, and wellbeing activities through exercise, using sports to build more united communities and stronger individuals. They may fund local sports facilities, tournaments, teams, and leagues that bring people together. They may be used to invest in infrastructure that supports the local community.

To make an application you can simply follow these steps:

Create a Profile on whatimpact.com

Sign up on the website with your email and create a password. Select which type of organisation you are and begin creating your profile. We will provide a Word template to help with this. You need to add an overview of your organisation explaining who you are, the areas you address, and who your beneficiaries are.



Add an Activity

This is where you should explain the project that the funding is for. Make sure you explain how you will meet the criteria of the grant you are applying to. Explain what the money will go towards and who it will help. You must have an activity published to apply.



Apply!

Go to the Newport City Council profile and click 'Apply'. You will need to answer some short due diligence questions and then you are done! It is very simple to apply using your profile and once you have applied you will hear back within a couple of weeks with any questions or if the grant has been allocated.

Rhaid i brosiectau fod o fudd i'r gymuned leol naill ai'n uniongyrchol neu drwy fanteision a grëir gan e.e. nifer gynyddol o ymwelwyr a chyfleoedd busnes. Mae'r grantiau'n gyfyngedig sy'n golygu bod yn rhaid eu defnyddio ar gyfer y prosiectau/gweithgareddau a gyflwynir yn y broses ymgeisio yn unig. Mae maint y grant yn amrywio o £1,000 - £30,000.

Gellir dyfarnu'r grantiau chwaraeon ar gyfer prosiectau fel digwyddiadau chwaraeon, gweithgareddau clybiau chwaraeon, gweithgareddau iechyd a lles drwy ymarfer corff, gan ddefnyddio chwaraeon i greu cymunedau mwy unedig ac unigolion cryfach. Gallent ariannu cyfleusterau chwaraeon, twrnameintiau, timau a chyngreiriau lleol sy'n dod â phobl ynghyd. Gellir eu defnyddio i fuddsoddi mewn seilwaith sy'n cefnogi'r gymuned leol.
